# **Pentecost Holy Day Offering**

In just over one week we will be celebrating the annual Feast of Pentecost. Each holy day has its unique message, reminding us of God's plan of salvation for all mankind. One of the unique aspects of our traditional observance of these holy days is the giving of a special holy day offering. In Deuteronomy 16:10 God said through Moses, "Then you shall keep the Feast of Weeks to the LORD your God with the tribute of a freewill offering from your hand, which you shall give as the LORD your God blesses you."

Through the years, the generosity of God's people in giving these holy day offerings has provided a significant portion of the Church's annual income, and we would like to thank you in advance for your loyal support and diligence in following God's instructions.

Since most of you will be preparing your holy day offering prior to the day of Pentecost, we wanted to give you a few quick reminders that will help us in processing your offering.

- 1. Wherever possible, please use the blue envelopes provided by the Church.
- 2. Please remember to write your personal donor envelope number beneath the date in the upper left-hand corner of the envelope. (Your personal donor envelope number was printed on your annual receipt.)
- 3. Please be sure your complete name and address are printed on the front of the envelope. (Yes, this is important even if you write your donor envelope number as requested.)
- 4. Most areas will process the offerings locally, so checks should be made out to: COG-East Texas.
- 5. The envelope should include only your holy day offering for Pentecost. Including any additional items makes processing much more complicated, so please do not include tithes, offerings for other holy days, notes, etc., in the envelopes.
- 6. Please clearly write the amount of the offering in the lower right-hand corner of the

# **Festival Assistance**

Each year many faithful brethren contribute extra funds from their festival tithe so that other needy members can receive the financial assistance they need to attend the Feast of Tabernacles. Last year these generous contributions enabled over 250 people to attend the Feast who would have been un-

able to attend otherwise. The Church recognizes its responsibility to see that those contributions are distributed fairly and equitably.

If you have no tithable income or if you have faithfully saved your festival tithe and will still not have sufficient funds to attend the Feast this year, we will be happy to help where we can. If you think you will need additional funds to be able to attend the Feast this fall, please contact our local Festival advisers Mr. Eric Case (East Texas), Mr. Chris Teague (Ruston), or your pastor to get a Festival Assistance Member Information form. Complete the form and return it as soon as possible. (All information on the form will be treated as confidential.)

Ministerial Services has asked us to have all assistance applications turned in by June 29, so please pick up the form and return it to your congregation's Festival adviser or your pastor as quickly as possible.

Again, Festival financial assistance is available for those who do not have a tithable income and for those who do not have adequate funds to attend the Feast even though they have faithfully saved their festival tithe.

#### **Excess Festival Tithe**

Through the years many of us have seen and experienced a variety of ways in which God has fulfilled His promises to bless those who faithfully tithe. While some members have little or no tithable income, the generosity of their spiritual brothers and sisters has enabled hundreds to share in the blessings

of the Feast of Tabernacles each year. On their behalf, we wish to extend a warm "Thank You!" to those who have shared their abundance.

Once again this year we will be able to provide financial assistance to those brethren who would be unable to attend the Feast without help. Government regulations permit charitable organizations to provide a modest amount of financial aid to those in need so they can share in this kind of religious activity. Therefore, we have established policies and procedures that allow the Church to legally, fairly, and equitably provide this special benefit to members who qualify.

To accomplish this, your help is important. If you are able to contribute excess festival tithe to be used to help your brethren attend the Feast, please begin sending in those funds to the Church mailing address in Dallas. #### Tithe of the Tithe

Years ago the Church of God established a tradition of asking members to contribute a tenth of their festival tithe – known as a "tithe of the tithe" – to the
