Branson Presidents Day Family Weekend Feb. 16-19, 2024

Plans are well underway for the 28th annual Presidents' Day Family Weekend in Branson, Missouri. The weekend will include seminars, activities and plenty of time for fellowship! You won't want to miss it.

IMPORTANT: Due to factors beyond our control, we will *not* be using the Grand Plaza Hotel this year as planned. I apologize to those who spent time—days, in some cases—trying to make a reservation. We have learned that the Grand Plaza Hotel will be closed for the foreseeable future.

What you need to know:

1. If you made a reservation with the Grand Plaza Hotel, it has been canceled. The Grand Plaza Hotel informed us that they did not charge a deposit on anyone's credit card, so you should not see a charge from the Grand Plaza Hotel. However, it is always good to monitor your credit

- card statement (in case you provided your credit card information).
- 2. We have secured the Stone Castle Hotel and Conference Center at 3050 Green Mountain Drive in Branson. The hotel rooms, conference rooms and the breakfast area are located in three separate buildings on the same property, so there will be some walking between buildings. The property has two indoor swimming pools and the Tracks Family Game Room. Since this is an entirely new location, you must call to make a reservation.
- Standard double queen rooms with microwave/mini refrigerator are \$50 per night plus tax (\$56.18 total).
- King Jacuzzi rooms with microwave/mini refrigerator (limited supply) are \$70 per night plus tax (\$78.65 total).
- Family suites with two separate bedrooms and two bathrooms (good for a family) are \$100 per night plus tax. (Only two are available.)
- A hot breakfast (with turkey sausage) is provided each morning.

FI Continuing Ed

Foundation Institute, Center for Biblical Education, is pleased to announce that this summer we will again hold two sessions of Continuing Education seminars at the headquarters office in McKinney, Texas.

Both sessions will be held in the Foundation Institute classroom, which has a capacity for 36 students.

The first session will be July 15 to 19, and the second session will be July 22 to 26. Classes will be taught by Foundation Institute instructors David Johnson and Ralph Levy, as well as other ministers from the headquarters office. Approximately 29 hours of Bible instruction will be taught. Details about class offerings will be announced at a later date. Class offerings will be similar for both sessions, but they may not be identical. Because of space limitations, students may be accepted for only one of the two seminars, not for both.

The tuition cost is \$100 per person, or \$150 for a married

couple. The fee will cover administrative costs and a light lunch each day.

Registration will open at 10 a.m. Central time (Texas time) on Sunday, Feb. 18, 2024, and will remain open until 10 a.m. Central time on Monday, Feb. 26. During this time you may sign up by going to the Foundation Institute website (foundationinstitute.org), selecting "Continuing Education" and clicking on the "Register Now" button.

This year we will use a similar system to what we used last year (2023) for accepting participants. All are welcome to apply, but priority will be given to those who have not attended a seminar since 2018. Last year all applicants were accepted, and it is our hope that this year we will again be able to accommodate all of those wishing to attend. But if it is necessary, this priority system will eliminate the firstcome-first-served system and will prioritize those who have not attended a seminar since 2018.

Those accepted will receive a confirmation email and further details about the program. Information about local housing will also be sent to those accepted for one of the seminars.

We look forward to seeing you here in Texas for our 2024 Continuing Education seminars. As they say here in Texas, y'all come!
