FI Continuing Ed

Foundation Institute, Center for Biblical Education, is pleased to offer two summer Continuing Education seminars at the headquarters office in McKinney, Texas.

Each weeklong seminar will be held in the Foundation Institute classroom (limited to 36 students per session) on July 13-17 and July 20-24, 2026. Instruction—approximately 29 hours of Bible classes—will be provided by FI instructors David Johnson and Ralph Levy, along with other headquarters ministers and faculty. Class offerings will be similar between sessions, though not identical, and participants may attend only one session.

Tuition is \$100 per person or \$150 per married couple, which includes administrative costs and a light lunch each day.

Registration opens at 10 a.m. CDT on Sunday, Feb. 8, and closes at 10 a.m. CDT on Monday, March 2. To apply, visit foundationinstitute.org, select “Continuing Education,” and click on “Register Now.”

All are welcome to apply. As in previous years, priority will be given to those who have not attended a summer seminar since 2019. Accepted participants will receive a confirmation email after registration closes, along with details on housing and payment.
